MSM PRAI TEMPORARILY HALTS REFINERY OPERATIONS ON COVID-19 CASES

KUALA LUMPUR, JUNE 9, 2021 – MSM Prai Berhad (MSM Prai), a wholly-owned

subsidiary of MSM Malaysia Holdings Berhad today announced that it had on 8 June 2021

received a notice from Kementerian Kesihatan Malaysia to temporarily stop its operations

commencing around 5:00 pm on 8 June 2021 until 17 June 2021 for the disinfection of

premises in curbing the spread of Covid-19 to safeguard the health, well-being and safety of

all the MSM Prai's employees and the local community.

Currently, all 756 employees at the premise including the contract workers which are over 92

percent Malaysians had undergone testing over a two-day screening period as a proactive

measure. The total 8 persons tested positive were immediately placed under quarantine with

subsequent contact tracing for further testing. The temporary closure will allow plant wide

sanitisation to be carried out for disinfection.

The management foresees that the temporary suspension of operations shall delay the

shipment of several sales orders to its customers. The management is currently in

discussions with the respective customers for the extension of time on deliveries and expects

no adverse impact to the Group in view of the long-term relationship with the respective

customers.

MSM Prai is expected to resume its operations on 18 June 2021 or earlier, subject to the

approval of the health authorities. The impact of the temporary stoppage to the Company's

revenue and earnings in the financial year ending 31 December 2021 are currently being

assessed.

MSM will calibrate the operational reliability strategy to ensure business continuity and

minimise the adverse impact particularly in fulfilling the demand and ensuring sufficient

stocks within the closure period. To further mitigate the situation, MSM will be exercising full

allowance of its permit to import refined sugar in addition to its current stock levels.

"Our operational premises strictly adhere to strict standard operating procedures (SOP) and

preventive measures as enforced by regulatory bodies. There were no cases of infection



reported in 2020. Country is presently at critical levels in reported daily cases. Threats from various sources are prevalent to all employees. The health, safety and well-being of our employees continues to be of utmost priority to us. Therefore, we will continue to monitor the situation and ensure the necessary healthcare assistance is being provided for all the affected employees. Moving forward, we will impose more stringent mitigation measures with testing, tracing and promote the effectiveness of vaccination. MSM has applied for the vaccination programme to the authorities under priority request as essential food producer and look forward to the organisation wide implementation," said MSM Group Chief Executive Officer, Syed Feizal Syed Mohammad.

The Group remains optimistic that MSM Prai will be able to ramp up its production once the operation recommences soon while sugar imports are in place now as mitigation to support the national demand averting any short supply crisis in the market.

Aside from household consumers, MSM sells to a wide range of customers in Malaysia and in other countries directly and indirectly through traders, wholesalers and distributors.
