

MSM PROFIT BEFORE TAX (PBT) ROSE 125% TO RM81 MILLION FOR FY2021

KUALA LUMPUR, FEBRUARY 22, 2022 – MSM Malaysia Holdings Berhad (MSM) posted a Profit Before Tax (PBT) of RM81 million for the 12 months ended 31 December 2021 (FY2021), against PBT of RM36 million in the corresponding period last year, although operating in a challenging environment with rising production cost, higher NY11 and freight cost. During FY2021, gain from disposal of MSM Perlis Sdn Bhd amounting to RM92 million has contributed to the Group recording a total consolidated PBT of RM170 million.

The Group also recorded higher revenue of RM2.26 billion for 12 months FY2021 compared to RM2.18 billion in the last financial year. The improved revenue for the quarter under review, RM642 million for 4Q 2021 compared to RM630 million for 4Q 2020 is mainly contributed by higher premium but hampered by lower volume due to reduced demand as consumption have not recovered to pre-COVID level.

During the quarter under review, the flash floods on 18 and 19 December affected major parts of Selangor. The Group's temporary refined sugar warehouse located at Kota Kemuning was also affected by the floods and has initiated insurance claim in respect of the affected inventories. Currently, for full assessment of damages is in progress.

MSM Group Chief Executive Officer, Syed Feizal Syed Mohammad said, "MSM has made good progress on its turnaround plans in 2021 amidst the rising trend of main production cost elements. On the domestic front, the positive development of the National Recovery Plan has provided strong impetus for greater economic recovery and socio-economic activities leading to more product consumption including sugar."

Operationally, the production cost for the Group increased as compared to the previous year driven by 18% increase in NY11, 69% increase in freight cost and lower utilisation factor (UF) due to temporary shutdown in MSM Johor for boiler rectification works and MSM Prai for sanitisation work due to COVID-19 as required by the Ministry of Health. The increase in NY11 was outweighed by lower foreign exchange of 2%.

"Internally, MSM Johor managed to improve its production yield as well as its UF although the plant is yet to achieve breakeven capacity level. On the export market, barring unforeseen circumstances, FY 2022 poses good opportunities within the Asia Pacific region that has a strong and growing demand. Besides strengthening MSM market position in Vietnam, China, Singapore and South Korea, we have large anchor contracts with the likes



of Coca-Cola recently awarded over the next two years as example. Such contracts allow the expansion and access into new markets such as the Pacific Islands. We hope to also enhance our market into Australia and New Zealand in addition and plan for penetration into the Philippines and Indonesia." added Syed Feizal.

MSM remains cautiously optimistic towards sustaining its financial performance in 2022 and will continue to drive its Environmental, Social and Governance (ESG) framework through a wide range of ongoing initiatives such a collaboration with Wilmar Sugar Pte. Ltd. in establishing a sustainable sugar supply chain and new initiatives designed to achieve a holistic sustainable growth. MSM will also be embarking on Net Zero carbon emissions and plans are underway. "ESG is not about compliance but simply the right thing to do and I am proud of MSM step-up efforts." added Syed Feizal.

Aside from household consumers, MSM sells to a wide range of customers in Malaysia and in other countries directly and indirectly through traders, wholesalers and distributors. Its customers include major companies in the beverage and confectionery industries, hotels, restaurants and food outlets.
